

**HUD Continuum of Care Program Competition Timeline
Fiscal Year 2024 and Fiscal Year 2025**

The HUD Continuum of Care (CoC) Program competition timeline is determined upon release of the HUD COC Homeless Assistance Grants Notice of Funding Opportunity (NOFO). The County of Macomb/Macomb Community Action (MCA) is the HUD approved Collaborative Applicant for the Continuum of Care Collaborative Application. In this role, MCA is responsible for leading and managing the decision-making and application process for the HUD Continuum of Care Homeless Assistance Grants application for projects seeking both renewal and new funding.

July 31, 2024	HUD NOFO is released.
August 1, 2024	FY 2024/FY 2025 CoC Application, the FY 2024 CoC Priority Listing, and FY 2024 Project Applications available in e-snaps.
August 13, 2024	HUD CoC NOFO webinar
August 16, 2024	<p>Start of Macomb CoC local competition. Macomb CoC Application and Rating and Ranking documents sent to CoC Membership and posted on Macomb CoC website.</p> <p>Applications for renewal projects, existing renewal project expansion, DV bonus (if available) and new projects (if funding is available) will be accepted.</p>
August 21, 2024 Webinar: 9 a.m.	MCA hosts a webinar for new and existing applicants to review the grant application process, rating and ranking.
September 13, 2024	<p>Deadline for local competition.</p> <p>All new and renewal applications and required documentation must be submitted to coc@macombgov.org by 5 p.m. on Friday, September 13, 2024.</p> <p>Renewal applications must be completed in eSNAPS by 5 p.m. on Friday, September 13, 2024.</p>
September 16, 2024 Webinar: 2 p.m.	<p>Macomb CoC Grant Ranking and Compliance Committee review team members are assigned applications to review. Review team members verify that HUD and CoC Thresholds are met and rate (score) the applications. Completed rating sheets are submitted to coc@macombgov.org by 5 p.m. on September 23, 2024.</p> <p>Scores are compiled by the Collaborative Applicant.</p>
September 26, 2024 In-person meeting: noon-4 p.m.	Macomb CoC Grant Ranking and Compliance Committee review team members meet to rank the grants following the CoC Rating and Ranking policy.

September 30, 2024	The Macomb CoC Grant Ranking and Compliance Committee submits the Grant Rating and Ranking to the Macomb CoC Board for approval.
October 1, 2024 (CoC Board)	The Macomb CoC Board approves the Grant Rating and Ranking.
October 9, 2024 (CoC Membership)	The Grant Rating and Ranking is shared to the Macomb CoC Membership listserv and posted on the Macomb CoC website by 5 p.m. on October 9, 2024.
October 9, 2024	The Collaborative Applicant notifies applicants if their applications were accepted or rejected.
By October 16, 2024	New project applications must be completed in eSNAPS. Renewal project application revisions are completed in eSNAPS.
October 18, 2024	Collaborative Applicant submits completed draft Consolidated Application, Consolidated Application Priority Listing, and attachments to the Macomb CoC Board for review and approval.
October 23, 2024	Collaborative Applicant posts CoC-approved Consolidated Application, Consolidated Application Priority Listing, and attachments on the Macomb CoC website. Community members and key stakeholders, including CoC Membership and project applicants, are notified via email that the CoC-approved Consolidated Application is posted on the Macomb CoC website.
October 28, 2024	Collaborative Applicant submits Consolidated Application and Consolidated Application Priority Listing in eSNAPS.
October 30, 2024, 8 p.m. EDT	HUD deadline for submission of Consolidated Application and Consolidated Application Priority Listing in eSNAPS.

- Local deadline can be no later than 30 days before HUD competition deadline. No later than September 30, 2024.
- Notification to all project applicants no later than 15 days before HUD competition deadline. No later than Tuesday, October 15, 2024.
- No later than 2 days before the HUD competition deadline, must post Consolidated Application, Consolidated Application Priority Listing, and attachments to the Macomb CoC Membership and post on the Macomb CoC website. No later than Monday, October 28, 2024.
